River Roden Clean out – Mr Edwards reported that work had been carried out to clear the riverside behind The Mill but that the work did not extend beyond the railway bridge.

HGV survey - Mr Edwards stated that he felt the HGV survey was carried out over too short a time period to be of any use and he asked how much the survey had cost Shropshire Council to carry out.

Cllr Mellings responded that the new light on Mill Street will not require a road closure as the work will be carried out in the evening when the road is quieter. The day burning of the new lights and removal of the old columns on Mill Street are also due to be actioned in December.

b) HGV survey – To receive an update on the survey results and to agree the date and format of future meetings/drop in sessions to enable the Town Council and residents to discuss the results with Shropshire Council officers.

A discussion took place on this item and it was considered that in the interests of transparency any presentation of the survey's results to the Town Council should be open to the press and public.

<u>RESOLVED</u>:- to organise a special meeting of the Town Council on 12.1.17 at 7pm to receive a presentation of the results of the HGV survey.

- **121/16 Correspondence** to consider the following items of correspondence (copies enclosed).
  - a) Rotary Club to consider request that the Town Council takes on responsibility for floral planters at the entrances to the Town. Cllr Moyse declared a bias interest and took no part in discussions. A discussion took place on the need to ensure that the planters were well looked after as they were an entrance to the town for residents and visitors.

<u>RESOLVED</u>:- to agree to take on the management of the entrance planters and the Clerk was asked to develop a sponsorship scheme of the planters to cover costs of the additional maintenance.

b) To receive Mr Hand's emails of 21.10.16 and 8.11.16 relating to new streetlights on Mill Street and items raised at October meeting of the Town Council.

# **RESOLVED**:- to approve response to questions raised as follows

Vehicle Activated Sign Location - The resolution that was passed by the Town Council at its October meeting stated that the Town Council would include provision in the 2017-18 budget to allow for the purchase of a Vehicle Activated Sign (VAS) on Mill Street. No decision has been made whether it will be within the 20 mph zone, this decision will be made following discussion with the Highway Authority.

Mill Street Streetlights - The Town Council was informed by Shropshire Council in February that work to replace lights would take place in March 2016. This item was for information only and no maps of where the lights were to be located or details of column styles were included in the email therefore the item was noted by the Town Council.

c) SP Energy Networks Project update 2 - updated line route report and Stage One Consultation feedback report – for noting.

# RESOLVED:- to note the feedback report.

d) Wem WI – to consider request that the Town Council helps with the maintenance of 90<sup>th</sup> Birthday Commemoration trees. It was reported that when this matter was originally discussed the original agreement would be that the WI would have to take on all the future maintenance of the trees. In addition to this the location of the trees is not on an area of grass cut by the Town Council.

<u>RESOLVED</u>:- to respond that the Town Council is unable to offer the services of the Groundsman in looking after the trees as they are located on land not maintained by the Town Council.

Cllr Mellings was asked to request that a temporary CCTV is located by the recycling bins to prevent unwanted items being dumped as this was becoming a problem. Cllr Mellings responded that this was being considered by Bronze Level Task Force Team.
