Minutes of the Ordinary Meeting of Wem Town Council held on Thursday 27<sup>th</sup> April 2017 at 7 p.m.in the Roden Suite, Edinburgh House, New Street, Wem.

6 members of the public present.

Prior to the start of the meeting Sgt Claire Greenaway from Wem Safer Neighbourhood Team (SNT) reported on current issues the team was dealing with in Wem which include speeding and burglary of outbuildings. She stated that the crime figures for the town are relatively low and efforts are being focussed on identifying and addressing anti-social behaviour before incidents escalate. The Recreation Ground and Butler Sports Centre car park continue to be part of the nightly patrol plan. In addition to this speed enforcement is being carried out as and when resources allow.

A question was asked about the level of staffing in the Safer Neighbourhood Team (SNT) and Claire reported that the team was now up to staffing strength which includes 1 Sergeant, 1 Police Constable, 3 Community Safety Officers. It was explained that there are so many elements to the SNT role that resources do not allow for routine patrolling of the High Street to increase visibility, however people were visiting the police station to seek advice.

A question was asked about drugs in Wem and Claire reported that the police are asking residents to report problems and the team have been actively promoting the Crimestoppers number to try and gather information on the issue.

# **201/17 Public Participation Time** - a period of 15 minutes will be set aside for residents of Wem Town to speak.

Mr Edwards raised the following issues;

Roden Grove roadworks are causing a large amount of disruption to local residents and very little work has happened to date.

The suggested alterations to the direction of traffic along Leek Street and Chapel Street will have an impact on the site lines for the new houses being built on Leek Street. In addition to this it may also have an impact on the businesses in the area.

If Shropshire Council were to make Noble Street a one way street traffic should enter the street from Adams School as this may provide some relief if Maunds Corner is busy.

The road markings by the level crossing still need re-painting.

Mr Edwards also highlighted the number of missed appointments at the Doctors' surgery and stated that something needs to be done about this as it is very difficult to get an appointment when you genuinely need one.

Mrs Burton requested that the road sweeper cleans the gully on Butler Road properly. She also reported that Drawwell Walk continues to be a problem with its poor surface and dog fouling.

A resident reported that the issue of HGV's mounting the pavement to get past traffic was a particular problem in the town and she had been involved in a near miss recently. She urged the council to continue its campaign to find a solution to the problem.

## 207/17 Highway Issues

a) Mill Street Vehicle Activated Sign – for update.

It was reported that the original sign chosen by the council was felt by Shropshire Council officers to be too large for the site. In addition to this the Clerk had been informed that the sign would require its own post as the new lighting columns may not be strong enough to support a sign of this nature. Following a discussion it was:

RESOLVED:- to approve the order for the supply and installation of a Vehicle Activated Sign and feeder post.

**b) Wem Economic Forum –** To consider additional traffic measures put forward by Wem Economic Forum in response to the HGV Survey.

Cllr Dee reported that Wem Economic Forum had put forward a number of other suggestions that the forum would like the Town Council to support in relation to the HGV problems in the town. These included the implementation of loading restrictions on the High Street during peak times. Creation of a loading bay and disabled parking bay outside the Nat West and consideration being given to the alteration of the one way system currently in operation along Chapel Lane, Drawwell Lane and Leek Street. A discussion took place on whether changing the one way system would create additional problems as it could affect site lines of existing properties and businesses.

<u>RESOLVED</u>:- to request that Shropshire Council Highways is asked to consider the following proposals put forward by Wem Economic Forum in response to the HGV survey results;

- Creation of a loading bay and disabled parking bay in the existing parking bay outside the old Natwest Bank.
- Introduction of loading restrictions along the High Street during peak times - suggested times for restrictions would be during the morning rush hour and school finishing time.
- Chapel Street / Leek Street/ Drawwell Lane one way system to investigate whether alterations to the existing direction of traffic will alleviate pressures on the junction of High Street and Mill Street.
- c) Implementation of a one way traffic system along Noble Street (at request of Cllr Dee) to consider whether to support the proposal.

Cllr Dee reported that this proposal had been supported previously by the Town Council and that residents have requested that this proposal is re considered as the road is narrow and residents are experiencing problems with large vehicles accessing the street. A discussion took place and councillors were concerned that if the street were to be made one way which direction of travel would be the most suitable for residents and businesses on Noble Street.

<u>RESOLVED</u>:- to support the proposal and to request that Shropshire Council consider whether making Noble Street a one way street would be a viable option.
