a) to consider the following planning applications

i) **23/03256/FUL** Coach House At Rear Of, 73 High Street, Wem, Shrewsbury, Shropshire

Proposal: Change of use from a stable block to dwelling, single storey extension and associated external works.

RESOLVED:- to object to the application for the following reason

- **The proposals will result in additional traffic accessing the site at Maunds Corner. There is concern for highway safety at this point as this is an already dangerous section of highway for road users and pedestrians alike.**

ii) **23/03054/FUL** Stables Day Care Nursery, 20 Wemsbrook Road, Wem, Shropshire

Proposal: Conversion of an outbuilding formerly used as a Childrens Nursery to facilitate a change of use into 4 holiday flats.

Cllr Granger left the meeting and took no part in discussions.

RESOLVED:- to comment that subject to the fire authorities' comments being addressed, the Town Council does not have any concerns over this application.

Cllr Granger returned to the meeting.

iii) **23/03268/FUL** 94 Lowe Hill Road, Wem, Shrewsbury, Shropshire, SY4 5UT

Proposal: Erection of single storey rear extension and works to extend existing dropped kerb to the front of the property for parking for at least 2 vehicles, one vehicle for a disabled person in a wheelchair.

RESOLVED:- to comment that whilst the Town Council supports the proposed erection of a single storey rear extension it has concerns about the need for a dropped kerb as there is already adequate on road parking in the area and an existing vehicular access to this property.

iv) **23/03287/FUL** Butler Sports Centre, Bowens Field, Wem, Shrewsbury, Shropshire, SY4 5AP

Proposal: Erection of a temporary modular building on the site of the previous Wem Sports & Social Club which was demolished in 2021 to act as a clubhouse for Wem Town FC and the local community

Cllrs Barker, Meakin and Drummond left the meeting and took no part in discussions.

RESOLVED:- to support the application as it will be beneficial to the community.

v) Re-submission of Application **22/03272/FUL** – Unit 2 Central Car Park, High Street, Wem, SY4 5AA

23/03442/FUL Proposal: Erection of 5 No two bedroom bungalows (affordable) with associated external works.

The Town Council support the application as the development is less intensive and there is a need to redevelop this site. However, if the Council is minded to approve the application, then a condition must be placed on any permission that all future tenants of the properties must meet local connection criteria.
