The Town Council is concerned that the proposed extension in front of the garage will reduce the driveway of the property significantly. In the proposed plans no consideration has been given to the parking needs of the occupants of the property. The Council considers that the loss of parking space at the property will cause occupants and visitors to park on the highway which could cause road safety problems especially as the property is situated adjacent to a junction and on a corner.
