Cllr Dee updated the Council on the representations she had made to Shropshire Council to have the parking charging machines on Leek Street Car Park and Mill Street Cark Park changed to accept coins. It is hoped that the Mill Street one will be changed in the near future and that the tickets purchased from the main car park would cover the Leek Street Car Park. Concern was raised that use of the car park had decreased and it was requested that when Shropshire Council carries out its review of the new car park charges in July that the review compares total ticket sales, not just income received. A discussion took place on the increase in residents car parking permits and Town Councillors expressed the view that the increase was unacceptable.

<u>RESOLVED</u>:- that the Clerk contacts all Town Council's in the old North Shropshire District Council area requesting that a joint letter is issued from the Town Council and associated Unitary Councillors in objection to the unfair increase of residents parking permits in their towns.
