139/19 Fees and Charges for 2019-20 - to review the following charges as per recommendations of the Amenities and Services Committee.

The Council considered the recommendations of the Amenities and Services Committee in relation to fees and charges for Love Lane Allotment and Cemetery. a) Love Lane Cemetery – Interment and Memorial fees.

Resolved:-

That Love Lane Cemetery fees are not increased and remain the same as for 2018-19.

b) Love Lane Allotments - Annual rents.

Cllr Dodd and Cllr Towers left the room and took no part in discussions.

Resolved:-

- Not to increase any allotment rents for year 2019-20
- That the Town Council charge a £5 admin fee to all tenants regardless of plot size.
- That from 1.4.19 all new entrants onto the allotment waiting list are charged a non-returnable £5 deposit.

140/19 2019-20 Budget

a) To consider contribution requests received from larger organisations running services or facilities within the Town.

Prior to the start of the Town Council's discussion on the budget for 2019-20 it was suggested that the Town Council may wish to discuss in broader terms the expenditure budget it was hoping to achieve at the end of the process. A discussion took place and it was

Resolved:- that the Town Council would aspire to set a maximum precept of £316,462 which will equate to a 3% increase on a band D property.

b) Wem Town Hall Trust – to consider Trustee's response to Service Level Agreement.

Cllr Meakin left the room and Cllr Dodd took no part in voting.

Resolved:-

To approve the amendments to the Service Level Agreement and to agree a three-year contribution to Wem Town Hall Trust of £22,000 each year for a maximum of 3 years until 2022.

c) To consider the Town Council budget for 2019-2020

Each budget heading was discussed and the following decisions made:-

Lighting

Councillors were made aware of reduced energy charges but that there was still a need to continue with a replacement programme for the concrete columns.

Resolved:-to approve the Amenities and Services Committee recommendation that the Public Lighting Budget be set at £28,522.

Cemetery

It was reported that this budget included provision to replace the cemetery fence.

Resolved:-to approve the Amenities and Services Committee recommendation that the Burial Ground Budget be set at £7,580 including the contribution to Whitchurch Road Cemetery.

Allotments

The Clerk outlined the need to increase the budget slightly to cover increases in water charges.

<u>Resolved</u>:- to approve the Amenities and Services Committee recommendation that the Allotments Budget be set at £910.

Administration

The Clerk outlined that the recommendation of the Finance and Corporate Governance Committee was to decrease the administration budget as there was no longer a need to make provision to employ the services of a Data Protection Officer.

<u>Resolved</u>:-to approve the recommendation of the Finance and Corporate Governance Committee that the Administration Budget is set at £24,480.

Contributions

Other than the contributions agreed under item 140/19a a discussion took place on the need to allocate funds for Wem Economic Forum and for the awarding of small grants.

Resolved:- to approve the contributions budget of £13,300 with £5000 being allocated for grant awards and £1000 allocated for Wem Economic Forum.

Recreation

It was explained that the play equipment budget required increasing in order to put funds aside for new items of play equipment. In addition to this there was also a need to repair the wetpour safety surface under some of the play equipment.

Resolved:-to approve the recommendation of the Amenities and Services Committee that the recreation budget is set at £29,550.

Swimming Pool

In addition to the contribution agreed for Wem Swimming and Lifestyle Centre under item 140/19a it was reported that the budget for insurance and repairs be maintained at 2018/19 levels.

Resolved:-to approve the swimming pool budget of £67,300.

Staffing.

Resolved:- To approve the recommendation from the Finance and Corporate Governance Committee that the Staffing budget is set at £100,356.

CIIr Expenses

Resolved:-. To approve that the Cllr Expenses budget is set at £1,075.

Toilets.

It was reported that additional provision had been made in the budget as the cleaning contract was currently out for quotes.

Resolved:-. To approve the recommendation of the Amenities and Services Committee that the Public Toilets budget is set at £14,500

Bus Shelters

Resolved:-To approve the recommendation of the Amenities and Services Committee that the bus shelter budget is set at £1,020

Miscellaneous

Floral Planters

It was reported that there is a proposed increase in this budget due to the Town Council's agreement to take on the watering of the floral tubs on the High Street Resolved:- To approve the recommendation of the Amenities and Services Committee to set the budget for floral planters at £3,750.

CCTV

It was reported that an allocation in the budget would be put towards the upgrading of 1 of the Town Centre cameras.

<u>Resolved</u>:- To approve the recommendation of the Amenities and Services Committee that the CCTV budget is set at £5,000.

Town Transformation

The Clerk outlined that the funds allocated under this budget heading were for the Town Council to carry out specialist works associated with the development of new services / facilities in the town.

Resolved:-to allocate a budget of £10,000 to this budget heading.

Wem Economic Forum Traffic Working Party

The request that the Town Council make provision in the budget of £2600 to fund a pilot study into the reversal of the one way priorities on Drawwell Lane /Chapel Street and Leek Street for a period of up to 1 year was considered. The Clerk explained that if the scheme was to become permanent it may cost an additional £8000. A discussion took place and some Councillors expressed the opinion that schemes of this nature should be funded by the Highways Authority not the Town Council.

Resolved:-

- To allocate £2600 in the budget towards this project £1386 of this amount to be earmarked from any 2018-19 underspend.
- That the final decision on funding this project will be made in April 2019.

Income

The Clerk outlined the income budget and it was

Resolved:- to set an income budget (excluding precept) of £14,095.
